## AWIS WOOL MARKET REVIEW

Week Ending 25 November 2022 (Week 21)

The AWEX EMI finished 24¢ higher (+1.9%) in Australian currency and 3¢ higher (+0.4%) in US currency at sales in Sydney, Melbourne and Fremantle in Week 21.

31,822 bales were on offer nationally, compared with 31,498 bales last sale. 8.1% of the offering was passed in after 6.3% of the potential offering was withdrawn prior to sale. 29,242 bales were sold.

AWEX reports that the value of the Australian wool sold was \$42.8 million (\$1,464 per bale). The number of bales sold at auction this season is now 1.0% greater than in 2021/22.

The New Zealand Merino Company also offered 1,471 bales in Melbourne on Wednesday, of which 17.8% were passed in.

It was a much more positive market with gains across all AWEX Merino Micron Price Guides on both days. These gains led to overall increases of up to 3% when compared with the previous week. The gains continued into the Crossbred type in the South, but were not sustained in North.

The US Exchange Rate finished  $1.05\phi$  (-1.6%) lower to close at  $66.39\phi$  on Wednesday after the rise of 5.9% over the two previous weeks.

Buyers for China were dominant, with support from buyers for India and Europe

In other countries, Cape Wools advises that the South African Indicator rose by 2.94% in US currency during the week.

Looking ahead, offerings for the coming three sales are expected to range from 38,295 bales to 39,979 bales and to be 0.6% less than in the same period last year. This takes the forecast progressive difference to Week 24 to -1.1%. It is not yet known what the full impact of the continuing wet weather is having on shearing in the Eastern States with the most recent forecasts being for more rain.




