AWIS WOOL MARKET REVIEW

Week Ending 17 April 2020 (Week 42)

The AWEX EMI finished at 1292¢, 9¢ lower (-0.7%) in Australian currency and 25¢ higher (+3.1%) in US currency in a one day sale in Sydney, Melbourne and Fremantle in Week 42.

18,097 bales were on offer nationally, compared with 29,495 bales last sale. 23.1% of the offering was passed in after 15.5% of the potential offering had been withdrawn prior to sale. 13,917 bales were sold.

AWEX reports that the value of the wool sold was \$19.7 million (\$1,416 per bale), taking the season total to \$1.703 billion (\$1,678 per bale). The number of bales sold at auction this season is now 19.6% less than in 2018/19.

Exchange Rates again had a major effect on the expression of the market. The upward movement of 2.38¢ in the US Exchange Rate (+3.9% to close at 63.84¢ on Wednesday) resulted in an upward movement of 25¢ in the EMI in US currency since the last sale, but a downward movement a 9¢ in Australian currency.

The AWEX MPGs moved up slightly at the Superfine end before moving down over the remaining Merino micron ranges and falling more sharply across the Crossbred diameter ranges.

Buyers for China were again even more dominant because of the situations in Italy and India.

Looking ahead, offerings for the coming three sales are expected to range from 30,905 bales to 33,326 bales. Sales will revert to Tuesday/Wednesday. As mentioned last week, year-to-year percentage changes have little meaning at the moment because of the timing of Easter and of the impact of COVID-19.

In other countries, Cape Wools advised on Wednesday night that sales in South Africa will resume on Wednesday next week.

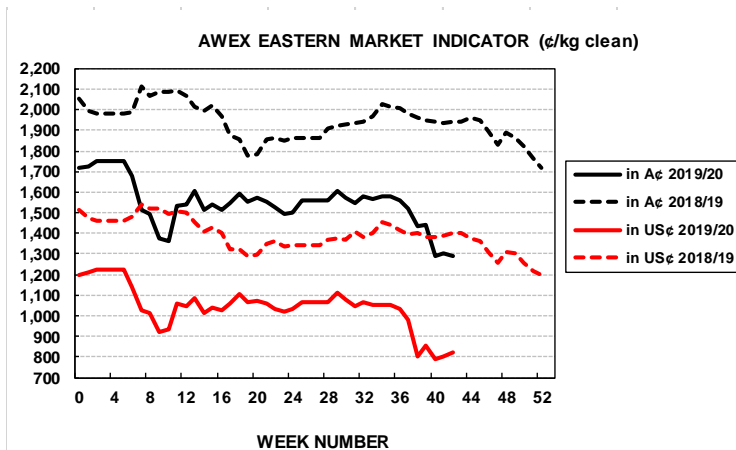

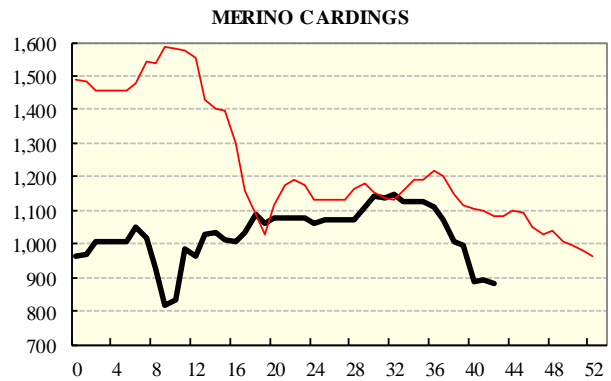
