## AWIS WOOL MARKET REVIEW

Week Ending 17 December 2021 (Week 24)

The AWEX EMI finished at 1358¢, 2¢ lower (-0.1%) in Australian currency and 4¢ lower (-0.4%) in US currency at sales in Sydney, Melbourne and Fremantle in Week 24. It was the last sale before the three week mid-season break.

40,889 bales were on offer nationally, compared with 38,106 bales last sale. 13.6% of the offering was passed in after 3.0% of the potential offering was withdrawn prior to sale. 35,315 bales were sold.

AWEX reports that the value of the wool sold was \$53.7 million (\$1,521 per bale), taking the season total to \$1.107 billion (\$1,612 per bale). The number of bales sold at auction this season is now 19.7% greater than in 2020/21. The difference between this season and last season is progressively decreasing due to the upward trend in offerings as sales progressed during last season.

The first half of the season finished on a relatively unchanged basis in the North and the South, but fell away later in the day on Wednesday when selling commenced in the West. Buyers generally displayed understandable caution in response to the ongoing uncertainty over the availability of shipping space.

The movements in most average AWEX Merino Price Guides were between plus or minus 0.5%. Crossbreds were more mixed, being down at the fine end and up at 30 microns.

The US Exchange Rate continued the downward movement seen since the end of October, when it finished 0.19¢ (-0.3%) lower to close at 71.14¢ on Wednesday. This was 5.5% less than at the end of October.

When the changes in average prices since Week 24 last year are looked at, the greatest changes varied from +27.5% at 16.5 and 17.0 microns down to +6.0% at 20 microns.

Buyers for China were dominant, with support from buyers for Europe and India.

Looking ahead, sales are in recess until Week 28, commencing on Monday 10<sup>th</sup> January.

In other countries, South African sales are in recess this week and will resume on 12 January.

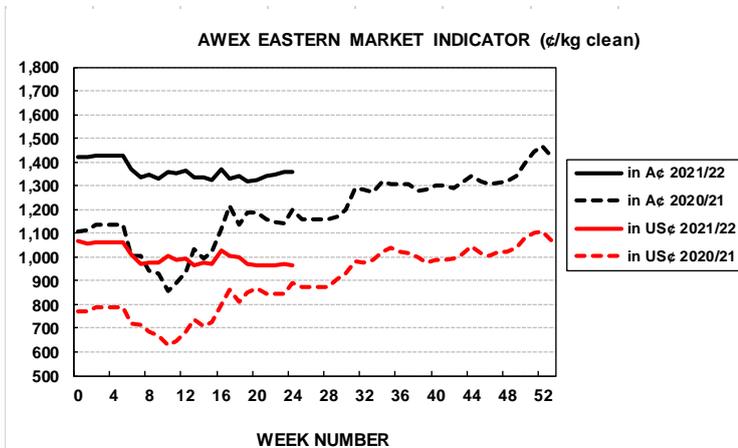

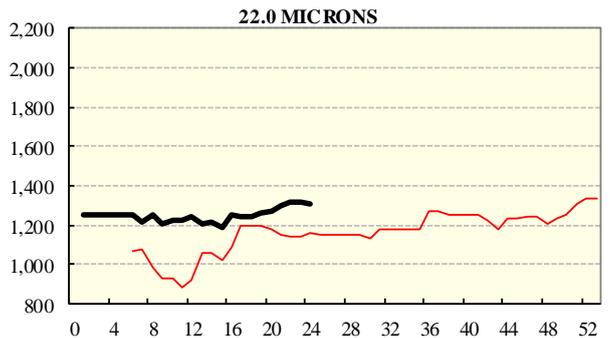

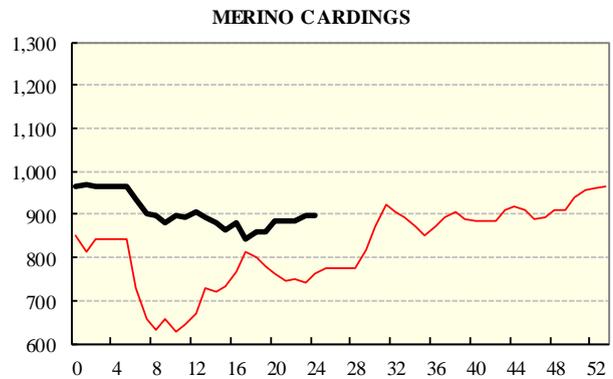
